Dunwich Wildfire

Ministerial Appointment to DEFRA



In July, I was incredibly honoured to be appointed Parliamentary Under-Secretary of State for Nature and Rural Affairs at the Department for Environment, Food and Rural Affairs (DEFRA).

Over the past two years, I've worked hard to champion the issues that matter most to Suffolk Coastal - from supporting our farmers and rural communities, to protecting our natural environment and standing up for our coastline. To

now have the opportunity to help shape Government policy on many of these issues is a real privilege.

When speaking after my appointment, I said that while Andy Burnham talks about applying the "Makerfield test" to Government policy, for me it will proudly be the "Suffolk Coastal test" - making sure we deliver better for rural communities, and better nationally and internationally for nature.

While I'll now have additional ministerial responsibilities, my commitment to Suffolk Coastal remains unchanged. My constituency team and I will continue supporting residents, progressing local campaigns, and working hard to make sure our communities have a strong voice both locally and in Government.

Thank you to everyone who has sent such kind messages following the announcement. Your support has meant a great deal, and I'm looking forward to getting started in this new role.

Summer Work Experience



Last month, I welcomed 10 young people from across Suffolk Coastal to take part in my first summer school programme, giving them the opportunity to learn more about politics, Parliament and community campaigning.

The first part of the programme took place in Westminster, where the group had the chance to go behind the scenes of Parliament, visit No.10 Downing Street, tour the estate and hear directly from Lord Deben - who was my own MP when I was their age - about his experiences in both the House of Commons and the House of Lords.

The second part of the programme is taking place here in Suffolk Coastal, where the young people will be learning more about the work I do campaigning on local issues. They will be speaking with residents to understand the issues that matter most locally, analysing the feedback they receive, and using what they learn to develop a small campaign.

Suffolk Coastal's 'Bus Desert'



Recently, I hosted my Big Bus Discussion in Saxmundham, bringing together residents, bus operators, Suffolk County Council and community representatives to discuss the future of bus services across Suffolk Coastal.

The meeting followed months of conversations with residents and responses to my Better Buses for Suffolk Coastal survey, which highlighted concerns about unreliable services, reduced routes and communities feeling increasingly disconnected.

There was a huge amount of passion in the room, with residents sharing their experiences of how poor bus connectivity affects everyday life. We heard from people struggling to access healthcare, education, work and essential services, as well as from many residents in villages where there is no regular bus service at all.

A key message from the evening was clear: people want to use buses, but services need to be reliable, better connected and designed around the needs of local communities.

I was pleased that First Bus committed to looking further at the potential for a coastal bus service and to reviewing where existing routes could be improved. Suffolk County Council also highlighted that residents and parish councils can submit requests for new services or improvements to existing routes through Suffolk On Board - <https://www.suffolkonboard.com/ways-to-travel/bus/report-apply-or-request/>

I will shortly be publishing my report on the findings from my Better Buses for Suffolk Coastal campaign, bringing together the experiences and suggestions shared by residents across the constituency.

Felixstowe Flooding



Earlier this month, I brought together residents, local councillors and key agencies for a flooding forum in Walton to discuss the ongoing issues affecting High Road West, Church Lane and surrounding areas.

Flooding has been a long-running concern for many residents, with repeated incidents causing disruption and frustration for households and businesses. I have been raising these concerns with the organisations responsible, but it was important that residents had the opportunity to hear directly from those involved, share their experiences and ask questions.

The meeting brought together representatives from Suffolk County Council, Anglian Water, the Environment Agency, Suffolk Police and local councillors to discuss the causes of flooding, the response so far and what more can be done to reduce future risks.

A number of actions came out of the discussion, including further investigations into drainage and gully maintenance, work by Anglian Water to model options for managing surface water, and follow-up on longer-term flood prevention measures. Agencies also committed to providing further

information on reporting routes, emergency planning and potential funding opportunities.

My team and I will continue to follow up on these actions and make sure the concerns raised by residents are not lost. I will keep working with the relevant organisations to push for practical solutions and better protection for communities affected by flooding.

Felixstowe Carnival



Last weekend marked one of my favourite weekends of the year - Felixstowe Carnival.

Every year, the carnival brings together the very best of Felixstowe, with local charities, community groups, sports clubs, dance schools and organisations coming together to take part in a brilliant programme of events for residents to enjoy.

From the procession through the town on Saturday, to the activities and performances taking place across the weekend, it was fantastic to see so many people getting involved and celebrating everything that makes Felixstowe such a special place.

What makes the carnival even more impressive is that it is organised and delivered entirely by a dedicated group of volunteers who give so much of their time and energy to make it happen. Bringing together such a large-scale event for the whole community is no small achievement - a huge thank you to the carnival committee, volunteers and everyone who took part in making the weekend such a success.

B1125 Rat Run



I recently brought together residents, parish councils, Suffolk County Council, Sizewell C and other partners for a roundtable discussion about ongoing concerns around road safety, speeding and increased traffic on the B1125.

The meeting, held in Middleton, gave communities from Blythburgh, Westleton and Middleton the opportunity to share their experiences directly with the organisations responsible. Residents raised concerns about increased

traffic, speeding, the challenges of managing a rural road and the potential long-term impact of changes linked to Sizewell C.

It was a constructive discussion, with a number of actions agreed, including further work on traffic monitoring, sharing data and modelling, and clearer information from Suffolk County Council about the process for considering speed limit changes and road safety measures.

I will continue to work with residents, parish councils and the relevant authorities to ensure these concerns are properly heard and that communities have the evidence and support needed to secure appropriate action.

Community Coffee Mornings



Thank you to everyone who came along to my latest village coffee morning in Knodishall.

My village coffee mornings are held in communities across Suffolk Coastal, with invitations delivered to every household in the village. They are an opportunity for residents to meet with me in an informal setting, raise local concerns and discuss the issues that matter most to their community.

In Knodishall, we had some really useful conversations, with roads and education among the main topics raised. Hearing directly from residents helps me understand the challenges communities are facing and ensures I can continue raising these issues with the relevant organisations and in Parliament where appropriate.

My next village coffee morning will be taking place in Sutton this September, and I look forward to meeting residents there.

Rubbish Bin Roll Out



I know many residents have continued to experience frustration with the rollout of East Suffolk Council's new waste collection service, with some households facing missed collections, delays receiving new bins, and confusion caused by unclear or changing information.

Since my last update, East Suffolk Council has publicly apologised for the disruption and acknowledged the scale of the issues. There have been some improvements, and I know some residents who had been waiting for collections have now had their bins emptied, which is welcome.

However, I am still hearing from residents who are experiencing problems, including missed collections and delays receiving new bins. Some people, including vulnerable residents, have faced particularly difficult circumstances after going weeks without a collection.

I will continue to raise these concerns with the Council and push for improvements.
