a. Public Participation - Parish Issues - An opportunity for parishioners to bring matters to the attention of the Parish Council and for parishioners to seek guidance from the Council.
 Cllr Nimmney: detailed that the Local Government Restructuring was continuing. Cllr Nimmney brought a printed copy of the 3 unitary authorities map for Councillors to review.

Cllr Nimmney also updated he attended the Newbourne biodiversity walk attended by several local parishes and councillors discussed a cross-parish biodiversity plan. Cllr Nimmney also provided a copy of a geed example of a biodiversity plan. Cllrs advised this work is being undertaken by the cross-parish working group.

a.i) <u>DC/25/1111/FUL</u>- Retrospective - Retention of residential use of former golf shop and associated works - Golf Shop, Waldringfield Golf Club, Newbourne Road, Waldringfield, Suffolk - <u>Planning Officer</u> - <u>M. Gavin; Deadline 01 September 2025</u>

Cllr Elliot presented on behalf of the planning group. She reviewed the planning history, ownership and enforcement action history the WPC was previously unaware of.

A retrospective application was received and the WPC responded on 14 May 2025, noting a holding objection. The WPC was unaware of the enforcement action involved at the time. WPC then responded to an appeal to enforcement action, re-stating our comments on the retrospective application.

Further submissions were received on the retrospective application to consider.

Cllrs agreed that comments made in the WPCs previous response was not resolved by the new documents, and therefore, maintain previously stated objection that the application does not comply with SCLP5.5, in particular the following requirements:

- b) The building provides a positive contribution to the landscape;
- g) The conversion enhances the immediate setting of the area

Councillors further discussed the following issues in their re-consideration of the application's new documents:

- Cllrs noted the number of recent applications where change of use to residential classification was granted, resulted in "replacing an existing dwelling" with substantially larger dwellings.
- Cllrs discussed that if successful, "permitted development rights" could allow further alterations, including extensions, without the need of planning permission
- Cllrs discussed, and did not agree with the applicant's agent that no structural survey is deemed necessary.
- Cllrs noted the "Proposed Floor Plan" can't be accurate as it does not include any provision for a kitchen which is contrary to the photographs provided.
- Cllrs were concerned that minimal detail of landscaping or planting has been provided, with this property being in the National Landscape.
- Clirs observed the block plan shows part of the access route is outside of the ownership of the
 applicant, and The Location Plan makes it clear that the driveway also serves the main car
 park of the "Clubhouse", which is under separate ownership and use, which would be a
 concern for future occupants

Cllrs discussed the application at length and opined the new documents did not satisfy the objections raised in the previous response and raised additional concerns as discussed above.

Motion to OBJECT to the application - Proposed Cllr Forsdike; Seconded Cllr Quick - all in favour

b. To **DISCUSS** response to ESC Planning Policy Survey

Cllr Elliot advised this is a survey related to the development of the new local plan and discusses communication with the Parish Council through the process. Cllr Elliot opined that the Parish Council should respond to this survey.

Clerk to circulate the questions and proposed responses for Cllrs review. Noted that deadline is the 03 September.
